

The CCCSAA Professional Development Scholarship will be given to a professional working in the field of student activities/student development while pursuing a degree at a college or university certificate program, specialized training, or licensed program. All applicants must be current members of CCCSAA.

The award will be given upon verification of certificate program, specialized training, or licensed program completed.

Amount:

Up to four scholarships of \$1000 each will be awarded at the end of the 2009-2010 academic year. *Number and amount will be based on the number of qualified applicants and committee recommendations.*

Deadline:

Fax/Email/Post Mark deadline: Friday, April 2, 2010

Transcript verifying completion of units and G.P.A. no later than Friday April 2, 2010

Applicants cannot receive this scholarship more than twice

An Eligible Applicant Must:

1. Be a professional who is currently working in the field of student affairs/student activities/student development.
2. Be working towards a degree or continuing his/her professional training in a field related to student activities/student development such as an certificate program, specialized training, or licensed program, OR have completed a minimum of six (6) semester units from an accredited college or university during the academic year of application while maintaining a minimum 2.0 cumulative G.P.A.
3. Be an Active Membership dues-paying member of CCCSAA during the academic year of application.

Selection Process:

1. Applications will be reviewed by the CCCSAA Scholarship Committee comprised of the CCCSAA Treasurer, the CCCSAA President Elect, Board member at large, and the north and south area representatives. Committee members are prohibited from applying for the scholarship.
2. The committee will select the scholarship recipient(s) by May 14, 2010.

- The completed application must be received by **Friday April 30, 2010**. If faxed, or e-mail, originals shall be sent and arrive no later five (5) working days after the e-mail or faxed copies are transmitted.
